Support to National Councils of National Minorities

The funds for the financing the activities of the national councils, entered in the Register of the national councils, are provided from the budget of the Republic of Serbia, the budget of the autonomous province and the budget of local self-government units, donations and other income. The amount of funds from public sources provided for financing the activities of national councils shall be determined for each year by the Law on Budget of the Republic of Serbia and decisions on the budget of the Autonomous Province of Vojvodina and local self-government units.

The funds provided for in the budget of the Republic of Serbia are allocated so that 30% of the funds are allocated among all registered national councils in the Republic of Serbia in identical shares and the residual value (70%) is allocated proportionally to the number of members of a national minority represented by a national council and according to the total number of institutions of a particular national minority in the field of culture, education, information and official use of language and script within the scope of activities of these institutions.

Financing the activites of the national councils of national minorities from the budget of local self-government units.

According to the Law on National Councils of National Minorities, the national councils representing a national minority that reaches at least 10% of the total population of a local self-government or whose language is in official use in the local self-government, shall be provided with the funds from the budget of local self-government units. On the basis of this law, 54 local self-government units are obliged to finance 12 national councils from their budgets, including: Albanian, Bosnian, Bulgarian, Vlach, Hungarian, Macedonian, Romany, Romanian, Ruthenian, Slovak, Croatian and Czech national minority. Office for Human and Minority Rights conducted a survey, in early 2014, among local self-government units and compiled the Communication on the implementation of legal obligations of financing the national councils of national minorities in local self-government units in 2014 year. In the 2014 budgets, allocations for the activities of National Councils was done by 25 local self-government units, while 29 did not envisage funds for these purposes. Three local self-government units planned funds for financing the national councils of the Rusyn and Slovak national minorities, Kulafor the national councils of the German and Ukrainian minorities and Novi Bečej- for the National Council of the Roma national minority.

Funding for associations and organizations of national minorities in AP Vojvodina, is also granted through Competition for grants to organizations of ethnic communities in AP Vojvodina, which is announced at least once a year. Only registered legal entities - organizations and associations of national minorities based in the territory of the Autonomous Province of Vojvodina, whose activity is based on preserving and cherishing national and cultural identity or whose activity is based on preservation and promotion of inter-ethnic tolerance, are entitled to participate in the competition.

According to a survey conducted for the purpose of preparing the **National Strategy for creating a supportive environment for the development of the civil society**, in the period from 2009 - 2014, a total of 26,042 civil society organizations were registered in the Business Registers Agency, 25,416 of which were associations and 626 foundations and endowments. Incusive of 9 October 2015, a total of 26,198 associations were registered in the Register of Associations kept with the Business Registers Agency, while 54 representative offices of foreign associations were registered in the Register of foreign associations. Organizations of civil society are engaged and active in different segments of social life, *inter alia* the fight against discrimination, provision of healthcare and social protection services, cultural development, youth and sports development, protection and tolerance towards vulnerable social groups.

Elections for National Councils of National Minorities

In the elections for national councils of national minorities, held on 26 October 2014, 171,799 members of 17 national minorities ⁹ (Albanians, Ashkalis, Bosniacs, Bulgarians, Bujevaks, Vlachs, Greeks, Egiptians, Hungarians, Germans, Romni, Romanian, Ruthenians, Slovakians, Slovenians, Ukrainians, and Czechs) registered in special electoral rolls voted for the members of their national councils. Members of Macedonian, Croatian and Montenegrin national minorities were elected to electoral councils as members of national councils.

Most of the funds for churches and religious communities is awarded through competition for grants to churches and religious communities which operate on the territory of the Autonomous Province of Vojvodina, announced at least once a year. One percentage of the funds which are not spent by the competition, is used for financing extraordinary and unforeseen demands of churches and religious communities.

The Ministry of Interior has continued with the implementation of Police activities with marginalized, minority and socially vulnerable groups, which primarily focus on the training of police officers on the rights of members of the groups and undertaking activities that will contribute that police activities are adjusted to security needs of these groups. In the area of police administration in Sombor, concrete cooperation with minority, marginalized and socially vulnerable groups was reflected in communication with the Association of citizens "Eureka", formed by a Roma women's non-governmental organization that deals with the socialization of marginalized social groups. In the area of police administration in Novi Pazar, a one-day seminar attended by 33 police officers on *Constitutional protection of human and minority rights* was held in 2012. Special attention was devoted to cooperation with the members of Roma national minority.

In 2011, within a joint project of the Ministry of Interior and the Republic of Hungary, in Novi Sad and Subotica, a six-month course in the Hungarian language was completed, as part of the learning of languages of national minorities in the Autonomous Province of Vojvodina. The course in the Hungarian language was attended by 40 police officers from police departments in Novi Sad and Subotica and the Regional Centre of Border Police at Hungarian border.

Police officers of the Police Administration for the City of Belgrade established cooperation and contact with the leaders and members of the Roma and their associations "Democratic Association of Roma", "Roma Children's Center" and others. In the area of police administration in Prokuplje a round table was held, organized by the Association of Roma on the topic of "Youth, for and against" In the area of police administration in Leskovac, in the premises of the Hall of the City Council, a meeting was held between members of the police and the representatives of Roma national minority on the topic of current security problems in the areas where the Roma live. At this meeting, it was stated that the cooperation between the police and Roma population is at a satisfactory level and it was proposed that the Security Council of the City of Leskovac engages the representatives of the Roma national minority. With the support of the OSCE Mission, the Ministry of Interior implemented, in 2012 and 2013, several local smaller projects aimed at preventing discrimination against minority communities.

The involvement of the **Basic Police Training Center in Sremska Kamenica** on the integration of the members of national minorities in the police and the Ministry of Interior, takes place, both on their own initiative and the initiative organized by or with the support of the Ministry of Interior, the Office for Human and Minority Rights, other government bodies,

educational institutions, non-governmental and international organizations, representatives of local authorities - and can be grouped into several areas:

- Promoting the profession of police officer, the Ministry of Interior and the Basic Police Training Center, information on training, the activities of the Centre, the requirements for admission and announced competitions through different media:
- Multilingual information campaign since the very founding of COPO, 2007, to mark the first competition for enrollment of students for training (brochures, posters, competition ads). Information material printed in nine languages, the most common of national minorities (Albanian, Bulgarian, Hungarian, Romani, Romanian, Ruthenian, Slovak, Ukrainian and Croatian).
- Through the electronic media website of COPO: www.copo.edu.rs and the page on the Facebook social network.
- Audio and video promotional material: For the campaign of the 2008 competition, a radio ad in the languages of national minorities and a promotional film were recorded. Within the project "Support for greater inclusion of national minorities in the police service" which began in 2012 and was completed in 2013, a 30-minute documentary informational and promotional film "School of Open Doors" was recorded on the inclusion of minorities in the police service (with the english/albanian subtitles) shown in 2013 at the RTS 2 in the series "The Citizen" dedicated to the life of national minorities in Serbia as well as a promotional 8-minute film about the Basic Police Training Center, for general purposes.
- The possibility of taking a part of the entrance examination for admission to basic police training psychological test and a test of general knowledge in the languages of national minorities These two tests have been translated into 8 languages of national minorities (Albanian, Hungarian, Romani, Romanian, Ruthenian, Slovak, Ukrainian and Croatian). With a wish to mitigate the aggravating factors and provide all candidates in the selection with the maximum of equal guaranteed conditions, the candidates from national minorities were enabled to take psychological test and test of general knowledge in their mother tongue. These two tests have been translated into eight languages of most prevalent minority ethnic communities (Albanian, Hungarian, Slovak, Romani, Romanian, Ruthenian, Ukrainian and Croatian). Testing of candidates on computers and complete automated processing of data allows a more objective, faster and better selection of candidates for basic police training.
- <u>Promotional stands of the Basic Police Training Center in the areas where there in a large number of members of ethnic minority communities:</u>
 - In February 2013, debates were held in Bujanovac, Vranje, Surdulica and Vladicin Han. In June 2013, debates were held in Sremska Mitrovica, Sombor, Subotica, Kikinda, Pancevo, Zrenjanin and Bor. In addition to the OSCE Mission, support in the implementation of the debates was also provided by the above police departments.
 - In March 201, the representatives of the Basic Police Training Center in cooperation with the OSCE Mission and the Bureau of International Cooperation and European Integration of the Ministry of Interior, as well as the authorized representative of the Roma, held promotional debates for the entry of potential candidates of Roma into the Basic Police Training Center. Debates were implemented in the presence of local media in Subotica (25 candidates), in Bujanovac (25 candidates), in Presevo (32 candidates), in Sremska Mitrovica (50 candidates), in the Police Department for the City of Belgrade (150 candidates), in

Uzice (120 candidates), in Valjevo (93 candidates), Bor (43 candidates), in Kladovo (52 candidates), in Pozarevac (211 candidates) in Kikinda (around 150 candidates). The realization of the debatess have also been supported by the above police administrations.

The aim and assignments of these activities are introducing the potential applicants to the characteristics and requirements of the profession, providing information about the Basic Police Training Center, duration and characteristics of the training, introducing people to the competition conditions and detailed information on the selection procedure (duration, selection phases, possibilities for preparation for the entrance exam). Encouraging Roma, Albanians, Romanians, Hungarians and women to apply for admission to the Basic Police Training Center is particularly emphasized.

- <u>Promotional and preparatory workshops</u> for the Basic Police Training Center <u>which</u> aim at better preparation of potential candidates for the entrance examination (psychological test, a test of general knowledge and Serbian language) Evaluation of selection of first and second-class studens of BPTC, showed that candidates from the majority of the environments with a larger number of minority ethnic communities, achieve relatively low pass rate in the admission exam compared to the average achievement and that such proportionally lower achievements cannot be atributed to less developed relevant basic skills, but to the lack of experience in test situations, as well as the fact that the candidates members of ethnic minority communities, are mostly educated in their own language and that, unfortunately, have insufficient knowledge of the Serbian language. Basic Police Training Center has, in the past few years established a program for better information of members of national minorities interested in enrolling in the Basic Police Training Center in order to ensure higher pass rate during the selection of candidates.
 - The workshops in November and December 2012 were realized in Presevo and Bujanovac with the support of the OSCE Mission in Serbia.
 - The workshops in March 2015 were realized within the project Inclusion of Roma men and women in the security sector of the Republic of Serbia the holder of which is the Police Association "European Roma Police Officers" with its headquarters in Belgrade. The funds for the project were prvoided through the Government of the Republic of Serbia - Office for Human and Minority Rights in the amount of 600,000 dinars. Six one-day promotional workshops were implemented in the Basic Police Training Center (11. 3. 2015), Belgrade (18. 3. 2015), Bor (23. 3. 2015), Kraljevo (24. 3. 2015), Pirot (25. 3. 2015. 2014) and in Nis (26. 3. 2015) Two press conferences aimed at informing the public and affirmation of the Project were held - one at the beginning of the Project realization in Belgrade and one at the end of its realization in Nis.
- <u>Participation at education fairs</u>:
 - The Basic Police Training Center has continued the tradition of SSUP, and has been participating in the Fair of Education "Guidelines" in Novi Sad for years, which was held in late February and early March in recent years.
 - The stock market of secondary schools (in the areas with a large number of members of national minorities): The Basic Police Training Center introduced in March and April 2013 to the students of primary and secondary schools in the Autonomous Province of Vojvodina (Rumenka, Kikinda and Subotica) and in 2014 in Kanjiza, with the significant presence of minority ethnic communities.

These events were organized within the project "Vocational guidance in Serbia - the stock market of secondary schools".

- <u>Open day</u>:
 - The Basic Police Training Center is visited by potential candidates who wish to get acquainted with the requirements for applying, selection of candidates, qualification exam as well as training and living and work conditions in the Basic Police Training Center. Special emphasis is placed on the visits of members of national minorities in the Autonomous Province of Vojvodina (2009, 2012 and 2014), the Roma community (2009 and 2011) and the Albanian minority members in Presevo, Bujanovac and Medvedja (2011. and 2012).
- <u>Serbian language classes for students of the Basic Police Training Center from the ranks of national minorities to enable them to follow the training at the Center more easily:</u> Since it has been reported that some of the participants of the Albanian and Hungarian nationality due to insufficient knowledge of the Serbian language had difficulties to follow the training, Serbian language classes have been organized for them.
- <u>Regional conferences/meetings in the context of the subject of this report:</u>
 - The Basic Police Training Center with the support of the Department for Democratization of the OSCE Mission in Serbia, have organized the international conference "Integration of minority ethnic communities in the police service" held in the Basic Police Training Center from 27 to 29 May 2013;
 - Representatives of the Basic Police Training Center took an active part in the international conference "Human Dimension Implementation Meeting" in Warsaw from 28 to 30. September 2014;
 - Representatives of the Basic Police Training Center took an active part in the regional conference "Interagency cooperation and prosecution of hate crimes in South-East Europe", Belgrade, 3 December 2014, organized by the Government of the Republic of Serbia - Office for Human and Minority Rights, the OSCE and the ODIHR.
 - Representatives of the Basic Police Training Center participated in the second coordination meeting of the representatives of the state authorities in order to establish a future mechanism for the fight against hate crimes in the Republic of Serbia, Vrdnik, 10 and 11 March 2014. Office for Human and Minority Rights of the Republic of Serbia with the help of the OSCE Mission.
 - Representatives of the Basic Police Training Center participated in the third coordination meeting of the representatives of the state authorities in order to establish a future mechanism for the fight against hate crimes in the Republic of Serbia, Aradjelovac, 25 and 26 November 2014. Office for Human and Minority Rights of the Government of the Republic of Serbia with the support of the OSCE mission in Serbia;
 - Representatives of the Basic Police Training Center took an active part in the Round Table "Treatment of persons deprived of their liberty and prevention of torture" held in the Assembly of the Autonomous Province Vojvodina, Novi Sad, 18 March 2014);
 - Representatives of the Basic Police Training Centertook an active part in the Presentation of research relationships of the criminal police towards discrimination - Implementation of anti-discrimination policies of the Ministry of Interior (KPA Zemun, 19 June 2014).

- Education of the Basic Police Training Center in the context of the subject of this report:
- A regional seminar Inclusion of national minorities in the police service has been organized;
- Seminar "Gender-sensitive actions in cases of gender-based and sexual violence against women" (Novi Sad, 20-21 February 2014);
- Seminar "Training of police officers on implementation of anti-discrimination policies" (realized in the Basic Police Training Center, 19-21 March 2014);
- "Training of police officers on implementation of anti-discrimination policies", (19-21 March 2014);
- Seminar "Police officer profession, ethics and police subculture" (Belgrade, on two occasions: 14 March and 24 April 2014);
- Integration of national minority communities in the police service (in the Basic Police Training Center, 27-29 May 2014, with the support of OSCE);
- Seminar "Standards in the field of human rights in police training", organized by TAIEX Department of European Commission Directorate General for Enlargement and European Neighbourhood Policy - 2 representatives (Brussels, from 2 to 3 July 2014).
- Training for conducting interviews by the PEACE model, organized by the OSCE Mission in the Republic of Serbia and the National Swedish Police Board, a total of four representatives of the Basic Police Training Center (Kovacica, two occasions: from 03 to 06 November 2014 and from 18 to 21 November 2014.);
- Advanced seminar on gender equality and non-discrimination December, 2014.
- <u>Improvement of the NPP and training in the Basic Police Training Center in the context of the subject of this report:</u>
 - On the platform for e-learning "Moodle", subdomain the Basic Police Training Center, the contents were updated and testing of students conducted in 2014, within the module Community policing and human rights and police ethics, and the subject Communicational skills in connection to this topic;
 - In April 2014 within the module Human rights and police ethics, 237 participants of eleventh class responded to the questions of the electronic survey on discrimination on the platform for e-learning "Moodle" subdomain Center;
 - Project "Gender perspective of human security," realized in the partnership of Autonomous Women's Center, ASTRA and Women in Black, with the support of the US Embassy in Belgrade - in the working group for monitoring and coordination of activities in cases of domestic violence, during 2014, engaged one woman representative of the Center. The guidelines intended for police officers who handle cases of violence against women were created within the Project. The document is a contribution to the efforts and activities undertaken by the Ministry of Interior for the adoption and implementation of the Special Protocol on Conduct of Police Officers in Cases of Domestic and Intimate Partner Violence against Women;
 - Participants of the 10th and 11th paid special attention, in 2013/14, during basic police training module "Community policing" and thematic areas of "Respect for equality" to the teaching unit of Equality police work in multiethnic and multicultural environment. From the subject Police ethics within the part dedicated to human rights units closely related to the topic covered by the Convention have also been elaborated, namely PE1.1: The concept of human rights, PE1.2: Guaranteeing human rights and fundamental freedoms of man,

protection systems and the role of the police in the protection and respect for human rights and PE1.3: Limitation of human and minority rights;

- According to the proposal of the new 2015 Curriculum, and in accordance with the International Convention on the Elimination of All Forms of Racial Discrimination, new teaching units in the subject Police ethics - human rights, have been introduced. Thease are teaching unit PE1.9: Prohibition of torture (Special attention is paid to situations with the highest likelihood and threat of torture or similar methods. For example, the first hours and days of arrest (preliminary investigation), while the person deprived of liberty is under the jurisdiction of the police.) and PE1.10: Sex and gender equality;
- According to the proposal of the new 2015 Curriculum in the subject Communication Skills, in 2015 a teaching unit VK 8.4 Linguistic intolerance and discrimination was introduced;
- According to the proposal of the new 2015 Curriculum, the teaching topic a special circumstance for assessment of sentence for committed offense of hatred Article 54a of the RS CC is taught within the teaching unit 1.9 on penalties from the criminal and criminal procedural law;
- According to the proposal of the new 2015 Curriculum, within the module of police powers, in part on requesting the notification, the PEACE model in which an emphasis is on non-discrimination and tolerance of police officers in communicating with citizens was introduced.
- The implementation of the second part of the training for emergency patrols (1-6th class) from the module Mental-tactical training, on the basis of a Training program for intervention patrols and Plan for the implementation of training for emergency patrols, organized by the Directorate for Education, Professional Development and Science and Police Administration in the Ministry. In training, special emphasis is placed on respecting human rights. The first part of training is implemented in the NC in Kula, and the second part at the Basic Police Training Center. In 2014, trainees were the police officers from the following municipalities: Police Administration for the City of Belgrade (four students), Police Administration in Novi Sad (four students), Police Directorate in Zrenjanin (two students), Police Administration in Kikinda (two students), Police Administration in Pancevo (two students), Police Administration in Sombor (two students), Police Administration in Sremska Mitrovica (two students) and Police Administration in Subotica (two students), Police Administration in Bor (20 students), Police Administration in Zajecar (20 students), Police Administration in Pirot (20 students), Police Administration in Prokuplje (20 students), Police Administration in Sombor (20 students), Police Administration in Subotica (20 students) and Police Administration in Cacak (20 students). Providers of the training are the trainers and co-trainers of the Basic Police Training Center and one police officer from the PI SDI, Police Administartion of Novi Sad.

The above promotional and information activities of the Basic Police Training Center contribute significantly to the positive image of the police in the community - especially among members of minority ethnic communities, as well as better information on the work of the Basic Police Training Center, the requirements for admission and selection of candidates. This is confirmed by the response of candidates, especially members of national minorities in the police administrations in the Republic of Serbia, where there is a large number of members of national minorities (Police Admistration of Novi Sad, Police Admistration in

Novi Pazar and Police Admnistration in Prijepolje, at the competition in 2012). The same trend continued in the competitions announced in March 2014.

Activities within the improvment of the Curriculum, training of students at the Basic Police Training Center in Sremska Kamenica as well as during practice of the students in participants in police administartions, activities in the field of education of employees in the Basic Police Training Center, as well as their participation in the education of the employees of the Ministry of Interior - the Basic Police Training Center aims to contribute to the improvement of work activities of the Ministry of Interior and the quality of the execution of the police tasks.

The Coordination Body of the Government of the Republic of Serbia for the municipalities of Preševo, Bujanovac and Medveđa

The budget of the Coordination Body for Presevo, Bujanovac and Medvedja in 2014 amounted to RSD 434,514,000.00. For the programs aimed at improving social conditions, which include providing support to vulnerable categories of the population and interventions in the field of education (student scholarships, scholarships for studying, buying school equipment for the first grade pupils of primary school) in the amount of RSD 43,750,000.00. The following was invested in the infrastrukuturne projects in 2011: 232,855,683.00 RSD; in 2012: RSD 222,080,840.33; in 2013: RSD 224,630,000.00; in 2014: RSD 246,602,000.00.

On the basis of the Program of measures for distribution and use of funds for subsidies for enterprises in the private ownership in the municipalities of Presevo, Bujanovac and Medvedja, the Coordination Body announced, as of 2012, a competition for grants and subsidies for small end medium-sized enterprises, entrepreneurs and agricultural cooperatives. At the competition in 2014, a total of RSD 49,756,286.30 was awarded for the incentive and development of 20 companies from three municipalities. Since the beginning of the program that encourages economic development and employment, RSD 149,338,418.10 RSD was invested in 57 companies with a projection of over 150 new jobs for the period of three years.

The Coordination Body for Presevo, Bujanovac and Medvedja annually allocate the funds for projects and incentives of civil society aimed at promoting inter-ethnic cooperation, encouraging youth activism, improving the living conditions of persons with special needs and resolving other issues important to the citizens of the three municipalities.

The Coordination Body for Presevo, Bujanovac and Medvedja announced in 2011 three competitions for the allocation of funds for civil society projects, approved RSD 13,723,027.00 and supported 28 projects of the associations. In partnership with PBILD program of the United Nations, a four-day training was organized in the first week of June 2011, for the representatives of non-governmental organizations from the region of Presevo, Medvedja and Bujanovac. The focus was on the organizations whose projects deal with solving and addressing youth issues. In 2012, three competitons were announced for the funds to support civil society projects and the media, RSD 7,789,880.00 was granted and 22 projects supported. In 2013, RSD 698,500.00 was approved and two projects supported. The associations have, with the support of the funds received in the competition, organized theater performances and workshops, training of journalists, study visits and many other activities that have improved the quality of life in Presevo, Bujanovac and Medvedja.

Also, the projects which promoted the development of education in southern Serbia were funded through the tenders. Two organizations from Bujanovac received the amount of RSD 797,500.00. 279

students from the fifth to eighth grade of elementary school *Branko Radicevic* in Bujanovac, of mostly Roma nationality, were given free textbooks. About 200 members of the Roma national minority students of secondary and primary schools in Bujanovac and Presevo were trained and enrolled in the secondary schools and faculties of their choice. One of the trainees enrolled at the Faculty in Novi Sad and became a scholar of the Coordination Body Service.

The European Partnership with Municipalities - EU PROGRESS, is a development program supported by the EU and the Government of Switzerland worth EUR 18.1 million for the period 2010 - 2013, with the aim to contribute to strengthening stability and socio-economic development of 25 municipalities in the south and southwestern Serbia. The program promotes participatory, accountable and transparent governance through the establishment of partnerships between civil society and local government institutions, the establishment of advisory services for citizens, support to local selfgovernment by organizing public hearings during the preparation of the budget, information and funds transfer to municipalities and enhancement of ethnic and gender equality of the decision-making process.

Support in the filed of culture

Financing activities of the members of national minorities in the field of culture is done from several public sources. In accordance with the Law on Culture, in addition to financing and co-financing of cultural programs in the institutions founded by the Republic of Serbia, autonomous province or local self-government, financing and co-financing of projects in culture and art projects, or professional and scientific research in culture at all levels of government is done from the budget of the founder and through annual tenders. The main holders of financing cultural activities are the Ministry of Culture and Information, Provincial Secretariat for Culture and Public Information, as well as local self-governments.

I. Financial support from the Republic budget

Ministry of Culture and Information in the allocation of public funds from the national budget allocates respectively the funds for the projects **in the field of cultural activities of national minorities.** The projects received to the announced competition shall be taken into consideration by an expert committee composed of the representatives of national minorities. The national councils of national minorities are also involved in the decision-making process by giving their opinions on these project. In addition to co-financing the projects in the field of cultural activities of national minorities, the Ministry of Culture and Information co-finances the projects, on the basis of the announced competition, *inter alia*, in drama arts, literature (events and awards) and audiovisual creation (film festivals, manifestations, workshops and colonies), the original national and amateur creativity, scientific research and educational activities in culture. The competition is open to institutions, organizations and other legal entities and individuals, including members of national minorities.

Protection, preservation and presentation of intangible cultural heritage

Bearing in mind that cultural heritage and its multifaceted form make an important part of modern identity of local communities and that it plays an important role in fostering cultural diversities, development of intercultural dialogue and protection of the cultural heritage of national minorities, the Ministry of Culture, fully respectful towards the prominent principles of the UNESCO Convention on the Protection of the diversity of cultural expressions, has particularly focused on this aspect of cultural heritage in the recent period. In the period **2010-2014**, the Ministry of Culture co-financed projects in the field of cultural heritage¹⁰ that encourage multiculturalism and projects of national

The National Councils take into consideration the applications to the announced annual tender and in accordance with their own determined cultural policy, they propose to the Provincial Secretariat for Culture and Public Information, the programs and projects to be co-financed in the current year, in accordance with the budgetary possibilities. At the same time, funds from the provincial budget, in the total amount over RSD 72,000,000.00 are used for co-financing the maintenance of total 766 programs of cultural and art events in the field of literature, art, theatre, music and musical-theatrical creations of 19 national minorities in Vojvodina. The largest share by the programs held in this period the is of the Hungarian national minority (326 programs), followed by Croatian national minority (86 programs), Romanian (80 programs) and Slovak national minority (77 programs).

Supporting information in the languages of national minorities

Competent authorities at all levels of government provide support to the realization of rights of national minorities to information in their own language and enrichment of the media in minority languages. The Ministry of Culture and Information has, in the financial reporting period, supported

these activities by calling the tender for co-financing of projects / programs in the field of public information in the languages of national minorities, by subsidies and through allocation of funds to individual projects. Provincial Secretariat for Culture and Public Information, on the basis of regulations and tender, allocated among other things, the funds for financing of newspapers of provincial interest, for co-financing projects of encouraging public information for the technical and technological advancement in the media and for improving the professional standards of public information. In the process of making decisions on the allocation of budget funds that support media and information in the languages of national minorities, active participants are the national councils of national minorities who give their opinions on the applicants' projects. Radio and TV stations whose founders are local governments are financed in in its entirety or partially from their budgets.

In 2010, on the basis of a special tender called for financing of print media in the languages of national minorities in central Serbia 3 newpapers were co-financed with a total of RSD 17,806,549.00. In 2011, because of the need of rationalizing the national budget, the funds intended for these newpapers and co-funding of programs/projects in minority languages on the territory of the Republic were consolidated. The funds in total amount of RSD 15,642,650.00 have been allocated for four newspapeps.

Measures to facilitate access to the media to increase tolerance and cultural pluralism

In order to encourage the production of media content that promotes respect for differences due to specific ethnic, cultural, linguistic or religious identity, the tender for financing projects / programs in the field of public information in the languages of national minorities includes, among others, the following criteria: contribution to the diversity of media content and pluralism of ideas and values, as well as the programs of multi and intercultural content with the aim of developing a culture of dialogue, better understanding and understanding among different communities. The tendency of an increasing number of media and productions that compete with multilingual and intercultural events was noted in the reporting period.

Besides through the tenders, the Ministry also supports individual projects estimated to improve quality of the public information system in the Republic of Serbia significantly.

Office for Human and Minority Rights announced, on the basis of the Law on Budget of the Republic of Serbia for 2013, Decree on the Means of encouraging programs or missing part of funds for financing programs of public interest realized by the associations (2012) and the Program for the use of funds for projects and programs of associations to promote and protect human rights in the Republic of Serbia for 2013, a tender for allocation of funds in the total of RSD 14,279,887.00 for the associations for project proposals for the realization of the following objectives: 1. Prevention and assistance in the implementation of policies in the field of asylum and readmission, with a special focus on the Roma population; 2. More efficient implementation of existing strategic documents concerning the position and status of Roma, through the creation of relevant reports and surveys 3. Improvment of quality of life of the Roma population through the creation and promotion of integrated local services/programs (inter-sectoral and inter-municipal) 4. Preventing and Combating Human Trafficking through innovative local programs and by raising awareness of the existing forms of human trafficking, with the focus on the Roma population. 5. 5. Encouraging the positive action of the general society towards representatives of the Roma population, as a socially vulnerable population in the field of migration - national, regional and the European Union. 15 civil society organizations were supported through the tender.

Within the program "Fight against discrimination and improvement of the position of vulnerable categories of the population" Office for Human and Minority Rights, on the basis of a public tender in 2013, allocated funds from the budget of the Republic of Serbia for 22 civil society organizations with the aim of improving the position of vulnerable categories of the population in the amount of RSD 20. 963. 381. The projects included all vulnerable social groups, the most significant projects being the objective media reporting, Festival "Free Zone" on improving the position of LGBT people, support for asylum seekers and returnees under the Agreement on readmission, etc.

The contest "Promotion of tolerance and equality aimed at improving the position of vulnerable groups", in 2014, the funding from the budget of the Republic of Serbia in the amount of RSD 16,693,772.50 was awarded to 22 civil society organizations for the implementation of activities to promote the following objectives: encouraging positive action of the society towards certain vulnerable social groups and towards individuals from these groups, such as co-members of ethnic minorities, women, LGBT people, people with disabilities, the elderly, children, refugees, internally displaced persons and other vulnerable migrant groups, persons whose health may be the grounds for discrimination, and towards multi discriminated persons; combating discrimination and raising public awareness about the importance of tolerance, equality and respect for diversity; promotion and enhancement of respect for the principles of equality and equal rights in order to prevent, or minimize all forms and special cases of discrimination of persons belonging to vulnerable categories of the population, who are often faced with multi discrimination persons, through the implementation of a series of activities to contribute the improviment the position of certain groups/minorities, promotion of the values and principles of inalienability of fundamental human and minority rights, in accordance with the program

The contest "Implementation of anti-discrimination policies in the Republic of Serbia in order to implement the Strategy of prevention and protection from discrimination" in 2015 supported 34 civil society organizations with the funds from the budget of the Republic of Serbia in the amount of RSD 18,927,000.00. The basis for defining the prioritization of the contest were the measures and activities envisaged by the Strategy of prevention and protection from discrimination ("Official Gazette of RS", No. 60/2013), Action Plan for the implementation of the Strategy of prevention ("Official Gazette of RS", No. 107/2014).

In the contest for associations' projects for the improvement of the position and status of Roma in Serbia, 15 associations were supported by the funds of RSD 14,226,837.00, which implemented the activities from December 2013 - March 2014, where three projects were aimed at inetsectoral connection in order to improve the position of Roma men and women in the local community, 5 projects to deal with the problem of readmission, 3 projects - human trafficing, 2 projects - encouraging positive actions of the community; 2 projects - improvement of healthcare protection in the informal settlements.

The contest for associations' projects for the improvement of the position and status of Roma in the Republic of Serbia, 24 associations were supported by the funds of19.961. 108,00, whose activities were implemented from November 2014 to March 2015. The following areas were covered: employment, healthcare protection, safety, education, readmission, forced marriage, domestic violence and violence against women, information campaigns on raising public awareness and encouraging positive action towards the citizens of Roma ethnicity.

The contest for associations' projects for the improvement of the position and status of Roma in the Republic of Serbia, 34 associations were supported by the funds of the budget of the Republic of Serbia in the amount of 17,000,000.00, whose implementation began in December 2015. The basis for defining priorities of the contest were the recommendations arising from the Operational conclusions from the Seminar on social inclusion of Roma men and women in the Republic of Serbia held in June 2015.

The Ministry of Youth and Sports and the OSCE Mission in Serbia, with the professional support of the Belgrade Centre for Human Rights in 2012 started the implementation of certified educational course for local coordinators of the youth office (YO) on the topic - Working with vulnerable young people and the principles of non-discrimination to provide support for the realization of one of the standards of the activities of YO - inclusive youth policy. The course was in the period from 2012 to 2015 attended by over 150 youth office coordinators of YO, their associates and representatives of youth associations and young people throughout Serbia. The Guide for working with vulnerable groups of the youth and the principles of non-discrimination was published in 2015.

Council of Europe Office in Belgrade in partnership with the Ministry of Youth and Sports and the Office of the Commissioner for Protection of Equality has been implementing the project "Live Library" in the Republic of Serbia since 2012. Live Library works exactly like a real library, where readers come and borrow "books" for a limited time. There is a single difference - books in the Live Library are people representing the groups frequently confronted with prejudices and stereotypes and who are often victims of discrimination, prejudice and social exclusion (people from disadvantaged minority groups, the Roma, people living with HIV, people with disabilities and others). Books and readers have the opportunity to make a real dialogue.

In accordance with the National Strategy for Youth (2008) and the action plan for its implementation from 2009 to 2014, the Ministry of Youth and Sports from 2011 to 2014 financially supported (over 11 million dinars) 18 projects implemented by the associations whose users are Roma and other ethnic minorities, aimed at their informal education, volunteering, strengthening the spirit of entrepreneurship, employment and spending quality free time.
